

## SLU + 180 days

La solicitud deberá presentarse con una antelación mínima de dos meses a la fecha de comienzo de la actividad a realizar, salvo que se acrediten causas justificadas que impidan la presentación en dicho plazo. The application must be submitted at least two months before the start date of the activity to be carried out, unless justified reasons (that must be accredited) prevent it from being submitted within this period.

### NOTAS:

1. Las personas que vayan a cursar un doctorado en España deberán solicitar un visado de residencia para investigación nacional (NO un visado de estudios). Con carácter previo a solicitar el visado, el interesado deberá obtener en España (en la Unidad de Grandes Empresas y Colectivos Estratégicos) una autorización de residencia para investigación nacional. NOTE: Individuals wishing to pursue a PhD in Spain must apply for a national research residence visa (NOT a student visa). Prior to applying for the visa, applicants must obtain a national research residence permit in Spain (from the Large Companies and Strategic Groups Unit).
2. Las actividades de investigación o prácticas no pueden tramitarse como visado de estudios, sino que deben tramitarse al amparo de la ley 14/2013 de Emprendedores. Research activities or internships cannot be processed as a student visa, but must be processed under Law 14/2013 on Entrepreneurs.
