		contain two blank pages. Passports issued more than 10 years ago will not be accepted.

		*Legalized and translated Shenasnameh: (Spanish translation for the last 6 month). If anyone has been born in Spain, he/she should provide it.
		* Photograph : A recent, 3.5*4.5,(for the last 3 month) color photograph,, taken against a light background, facing forward, without dark or reflective glasses, or any garments concealing the oval of the face.
		*Criminal record check certificate. (for the last 3 month): Applicants of legal age who apply for a visa for a stay of more than 180 days must submit the original and a copy of the criminal record check certificate(s) issued by their country or countries of residence for the past 5 2 years. Foreign documents must be legalized or apostilled and, where applicable, must be submitted together with an official translation into Spanish. Additionally, a declaration will be submitted stating that there is no criminal record for the last five years.
		Documents proving family relationship with the investor: birth or marriage certificates issued by the civil registry, certificate of registration as an unmarried couple or any other document proving that the relationship is an unregistered partnership.
